**In order to be correctly affiliated, Show Secretaries are requested to observe the following rules**

- Completed Affiliation Forms and the correct fee must be received by the Side Saddle Association (SSA) by **28th January 2024, TO ENSURE INCLUSION IN THE SSA MEMBERS’ SHOWS & FIXTURES LIST**, circulated to all Members and posted on the SSA Website. Shows Affiliating after 28th January 2024 will be included on the SSA Website listing, updated weekly.
- A copy of the relevant section of **draft schedules** MUST be sent to SSA Show Affiliations, for approval. Until the draft is **received AND approved** and the **name of your chosen Judge advised NO rosettes will be sent to you.**
- Please ensure the **wording for all classes** conform to those given in this Guide. If you would like any relevant **Class wording emailing in word format**, please do ask.
- Provided Draft Schedule wording has been approved, and your chosen Judge’s name advised Rosettes, Mark & Show Report Sheets, as appropriate, will be despatched at least 4 weeks prior to your Show, 2<sup>nd</sup> class with a receipt of postage. If you have not received your Rosettes, please contact SSA Show Affiliations, as soon as possible. Rosettes received but misplaced will be charged for at cost.
- **Overseas Affiliating Shows** requiring rosettes to be sent to them direct and not brought out from a UK address will be invoiced by the SSA Hon Treasurer for the additional cost, when it is known.

# 2024 GUIDE FOR AFFILIATING SHOWS

## FOR SHOWS REQUIRING SAFETY HATS TO BE WORN AT ALL TIMES

**Please note: ALL Shows affiliating to the Side Saddle Association (SSA), whose H&S and Insurance Policies, or the Venue's, require Safety Hats to be worn at all times should be aware that should they decide to waive the ruling for SSA classes, they do so at their own risk and the SSA cannot be held responsible for such a decision.**

### INFORMATION FOR ALL SECRETARIES OF AFFILIATING SHOWS

Show Secretaries are urged to contact their local Side Saddle Association Contact, [www.sidesaddleassociation.co.uk](http://www.sidesaddleassociation.co.uk) if they have any local queries, problems, difficulty in finding Judges, or need advice about Jumping or any other Classes.

### A. COMPETITION RULES

**FALLS:** A fall of horse/pony or rider in any class run under Side Saddle Association rules will result in disqualification, and the rider must leave the ring dismounted. It is strongly recommended that medical advice is then sought before competing in any other class.

**HORS CONCOURS:** Members competing Hors Concours will only be awarded 2 Qualifying Points; they may not receive SSA Rosettes, Show Rosettes or any Prize with the exception of Open and Junior Equitation Classes where LEAD REIN

competitors should be considered for the Junior Turnout rosette. Leaders must be correctly dressed.

**JUNIOR COMPETITORS (SSA Members or Non SSA Members):** **MUST** have attained their 5<sup>th</sup> birthday and be under 18 on 1<sup>st</sup> January of the current year and **MUST** wear a correctly secured Skull Caps/Riding Hat that meets **one of the following** current Safety Standards in all classes affiliated to or run by the SSA: All PAS 015; VG1; (BS)EN1384 2017; ASTM F1163 04a onwards; SNELL E2001; SNELL E2-17, AS/NZS 3838 2003 onwards. In addition the new BS/EN standard will be allowed, once approved with the finalised number being advised in due course. A Spur or Spur band is not permitted in any class where jumping is involved.

**LEAD REIN COMPETITORS (SSA Members or Non SSA Members):** **may only** compete **Hors Concours** in any SSA affiliated class **EXCEPT** the Best Horse/Pony Class and in a Junior or Open Equitation Qualifying Class. In an Equitation Class, they are not eligible for SSA place rosettes but should be considered for the Turnout Rosette. Leaders must be correctly dressed.

**ADULT COMPETITORS (SSA Members or Non SSA Members):** **MUST** be aged 18 or over on 1<sup>st</sup> January of the current year and **MUST** wear a correctly secured Skull Caps/Riding Hat that meets **one of the following** current Safety Standards in all classes: All PAS 015; VG1; (BS)EN1384 2017; ASTM F1163 04a onwards; SNELL E2001; SNELL E2-17, AS/NZS 3838 2003 onwards. In addition the new BS/EN standard will be allowed, once approved with the finalised number being advised in due course.

**QUALIFIERS:** Shows held up to and including the first day of the current year's National Side Saddle Show will be Qualifiers for this year's Show. Shows held after that date will be Qualifiers for the following year.

**CLASSICAL/CONTEMPORARY CLASSES:** Riders may only enter **either** the Classical OR the Contemporary class, not both, unless they have two horses/ponies of a different type

### B. MARK SHEETS, ETC.

Show Report Sheets and/or Classical Side Saddle Class Mark Sheets Results are provided by the SSA and should be returned to SSA Show Affiliations (together with any unused Rosettes) within 14 days.

### C. JUMPING CLASSES

Side saddle jumping classes are a crowd-puller and exceptionally popular. Shows wishing to offer them are invited to discuss the range of classes with their Area Chairman. You are asked, **IN THE INTERESTS OF SAFETY**, to request an SSA representative to walk and approve the course. All courses should be designed to encourage.

### D. ROSETTES PROVIDED BY THE SSA

Please note these Rosettes are additional to and do not replace a Show's own rosettes:

#### **The Side Saddle Association Equitation Classes:**

2 sets, 1<sup>st</sup> to 3<sup>rd</sup> places, Special for highest under 14 and 2 Turnout as detailed in class wording.

If applicable, **Sir Lancelot:** 1 special rosette

#### **Classical Ladies**

1 special rosette, as detailed in class wording

1 Mark/Result Sheet, 1 SSA and 1 BSHA Qualifying Card

#### **Contemporary Ladies Qualifying Classes**

1 special rosette, as detailed in class wording

1 Mark/Result Sheet, 1 SSA Qualifying Card

**Concours d'Élégance, Costume Concours d'Élégance, Riding Club Horse/Pony:**

2 special rosettes, as detailed in class wording

**Best Horse or Pony:**

2 special rosettes, as detailed in class wording

CHAPS offer a rosette to the highest placed coloured exhibit who qualifies, as detailed in class wording

**Additional Special Rosettes:**

SSA rosettes are available for Shows to purchase and award to the highest placed SSA Member, their current Championship Points Card riding side saddle in such classes as, Equitation Jumping, WH/WHP, Ladies Hunter, Ladies Hack, SS Show Pony, etc

**Special Notes for SSA Area Run Shows**

1. Please refer to the SSA Area Run Shows' Affiliation Form.
2. All Areas **MUST** appoint a representative to collect and sign for the Area's Rosettes for the Year at the SSA AGM. **Area Shows affiliating after the 2024 AGM will pay for their Rosettes to be delivered in the normal way.**



**SCHEDULE WORDING FOR 2024**

**FOR SHOWS REQUIRING SAFETY HATS TO BE WORN AT ALL TIMES**

**Please use the wording below for your scheduled SSA classes**

**EQUITATION CHAMPIONSHIP QUALIFYING CLASSES**

**PLEASE CHOOSE ONE OF THE TWO OPTIONS BELOW:**

**CHOICE 1 - Open Equitation**, open to Adults and Juniors. If entries warrant, an **Open Class** may be divided into an Adult and a Junior Class at the discretion of the Show. SSA Rosettes and Qualifying Points shall be awarded to Adults & Juniors as 2 sections: the highest placed Adult & Junior Members will receive SSA rosettes to 3<sup>rd</sup> place, and Qualifying Points down each line. The highest placed Member under 14 on 1<sup>st</sup> January of the current year will receive a rosette. **Competitors must wear a hat to current Safety Standard or above.**

**CHOICE 2 – Adult Equitation** and **Junior Equitation** separate classes with same rosettes as Choice 1.

- *The Judge shall be on the current SSA Judges' Panel*
- *Shows held up to and including the first day of the current year's National Side Saddle Show will be Qualifiers for this year's Show. Shows held after that date will be Qualifiers for the following year.*
- *In all equitation classes it is the rider and not the horse that is judged and qualifies and there will be no reference to the sex, breeding or conformation of the horse. However, horses should, in the opinion of the judge, have manners suitable for carrying a side saddle. Horses shall be 4 years old or over.*
- *Lead Rein Competitors may compete in a Junior or Open Equitation Qualifying Class. They are not eligible for SSA place rosettes but should be considered for the Turnout Rosette. Leaders must be correctly dressed.*
- *Competitors enter the ring together and are required by the Judge to walk, trot and canter on the right rein, followed by a change of rein through trot and canter left, before being called into a provisional order.*
- *Each competitor is asked to give a freestyle show to a maximum of 2 minutes, after which the competitor's turnout is inspected.*

**WORDING FOR CHOICE 1** (Please note this Class counts as two Classes for the Affiliation Fee)

**EQUITATION CHAMPIONSHIPS OPEN QUALIFYING CLASS**

Run under SSA Rules defined in the current Members' Handbook. Open to SSA Members and Non-Members. Members carrying their current Championship Points Cards are eligible for SSA rosettes to 3<sup>rd</sup> Adult and 3<sup>rd</sup> Junior places and SSA Championship Points. **Southernden Farm** sponsor a rosette to the highest placed Member aged under 14 on 1<sup>st</sup> January of the current year. A rosette sponsored in memory of **The Late Mr R Philpot** is offered to the Adult Member and **Just So Elegant Side Saddle Hire** sponsor a rosette for the Junior Member, judged to be the best turned out. **Competitors must wear a hat to current Safety Standard or above.**

**WORDING FOR CHOICE 2**

***The Side Saddle Association***

**EQUITATION CHAMPIONSHIPS ADULT QUALIFYING CLASS**

Run under SSA rules defined in the current Members' Handbook. Open to SSA Adult Members and Non-Members aged 18 or over on 1<sup>st</sup> January of the current year. Members carrying their current Championship Points Cards are eligible for SSA rosettes to 3rd place and SSA Championship Points. A rosette sponsored in memory of **The Late Mr R Philpot** is offered to the Adult Member, judged to be the best turned out.

**Competitors must wear a hat to current Safety Standard or above.**

***The Side Saddle Association***

**EQUITATION CHAMPIONSHIPS JUNIOR QUALIFYING CLASS**

Run under SSA rules defined in the current Members' Handbook. Open to SSA Junior Members and Non-Members aged under 18 on 1<sup>st</sup> January of the current year. Members carrying their current Championship Points Cards are eligible for SSA rosettes to 3rd place and SSA Championship Points. **Southernden Farm** sponsor a rosette to the highest placed Member aged under 14 on 1<sup>st</sup> January of the current year. **Just So Elegant Side Saddle Hire** sponsor a rosette to the Junior Member, judged to be the best turned out.

**Competitors must wear a hat to current Safety Standard or above.**

**QUALIFIER FOR THE SIR LANCELOT MEMORIAL TROPHY**

- *Only applicable to UK Areas (Area 20 cannot hold Sir Lancelot Qualifiers)*
- *For Shows (maximum of 2 per Area), invited by the relevant SSA Area Chairman, to hold a Sir Lancelot Qualifier*
- *The Judge shall be on the current SSA Judges' Panel but may be assisted by a Celebrity or Sponsor*

A Special rosette will be offered to the Adult Member, carrying their current Championship Points Card, of the **SSA Area in which the Show is organised**, who during the Equitation Qualifier Class (irrespective of final placing) is judged to be the most elegant. That member will be eligible to compete in the Final for the Sir Lancelot Memorial Trophy (donated by the late Mrs E. Skelton) at the National Side Saddle Show. A Member may only qualify once per season between one National Show and the next, and if the Judge's first choice has already qualified, the rosette will be awarded to the next eligible competitor.

\*\*\*\*\*

**SIDE SADDLE RIDING CLUB HORSE/PONY CLASS**

- *The Judge shall be on the current SSA Judges' Panel*

Open to horses and ponies 4 years old or over. Riders will be required to give a short show including a small jump, maximum 61cm (2'). The height may be adjusted during the course of the class at the Judge's discretion. The class shall be judged on the show, the manners of horse/pony and its suitability for the rider. Conformation will not be considered. A **Special rosette** will be awarded to the highest placed Adult and Junior Members of the SSA carrying their current Championship Points Cards. **Competitors must wear a hat to current Safety Standard or above.**

**BEST HORSE OR PONY RIDDEN SIDE SADDLE**

- *The Judge shall be on the current SSA Judges' Panel*

Open to horses and ponies 4 years old or over: conformation & manners will be taken into consideration; horses/ponies will not be stripped. A Special rosette will be awarded to the highest placed Adult and Junior Members of the SSA carrying their current Championship Points Cards.

The Highest placed **coloured exhibit ridden by a competitor aged 16rs or over** (who has not already qualified) receives a **Special Rosette** and qualifies for the Side Saddle Final at the **CHAPS Championship Show**. Open to any type of exhibit. Riders/Owners need not be a member or their exhibit registered with CHAPS at the time of qualification, but in order to compete at the Championships, the Rider/Owner must be a showing member and their horse/pony registered with CHAPS before entering the final. Lead Rein competitors are eligible for this class. Leaders must be correctly dressed. **Competitors must wear a hat to current Safety Standard or above.**

**SIDE SADDLE CONCOURS d'ÉLÉGANCE**

- *The Judge shall be on the current SSA Judges' Panel but may be assisted by a Celebrity or Sponsor*

The sole criterion for this class is the elegance of the picture presented by horse and rider. Attention may be paid to the rider's personal appearance but detailed inspection of rider or tack is not required. Fancy dress or period costume is not permitted. Competitors are required to walk, trot and canter. No individual show is required, but the Judge may ask groups of 3 or 4 riders to give short displays. A Special rosette will be awarded to the highest placed Adult Member and Junior Member of the SSA carrying their current Championship Points Cards. **Competitors must wear a hat to current Safety Standard or above.**

## SCHEDULE WORDING FOR 2024 cont ....

### SIDE SADDLE COSTUME CONCOURS d'ÉLÉGANCE

- *The Judge shall be on the current SSA Judges' Panel but may be assisted by a Celebrity or Sponsor*
- *Where this class is a main ring attraction Shows may, at their discretion limit entries to Adult competitors only and the rosette provided for the highest placed Junior will not be awarded.*

The sole criterion for this class is the elegance of the picture presented by horse/pony and rider, and the way of going of the horse/pony. Safe tack must be used. Detailed inspection of the rider's period costume is not required. Fancy dress is not permitted. Competitors are required to walk, trot and canter. No individual show is required, but the judge may ask small groups of 3 or 4 riders to give short displays. A Special rosette will be awarded to the highest placed Adult and Junior Member of the SSA carrying their current Championship Points Card. Competitors should produce a brief résumé about their costumes for the Commentator.

### THE SIDE SADDLE ASSOCIATION CLASSICAL LADIES SIDE SADDLE QUALIFIER

- *The Judge shall be on the current SSA, SHBGB or BSHA Judges' Panels*
- *A maximum of 3 per SSA Area for Area run Shows*

Open to SSA Adult Members and Non-members, aged 18 and over on January 1<sup>st</sup> of the current year, riding saddle, on horses exceeding 148cm (14.2hh). To be judged 25% conformation and action, 25% manners and way of going, 25% rider, and 25% turnout of horse & rider.. Judges may request a short show, but exhibits; but horses will not be stripped. Traditional habits must be worn. Fancy Dress and Period Costumes NOT permitted.

**NB** Silks Hats are permitted to be worn in this class AT ANY TIME OF THE DAY.

**Judges must use the mark sheet provided.** The highest placed horse/rider combination qualifies for the Final to be held at the National Side Saddle Show. In the event of previous qualification, the Qualification Card may be passed down to fourth place. The highest placed horse/rider combination qualifies for the Final to be held at the National Side Saddle Show. One special rosette and the qualification card will be given to the qualifying combination each show, this may not always be the winner. If the winner has already qualified they may be passed down to fourth place. *Qualifiers kindly sponsored by Mrs. T. Mitchell and Mr. L. Mitchell.* Qualifying combinations are required to become Full Members of the SSA 21 days prior to the National Side Saddle Show or as soon as possible if qualified after that date to be eligible to compete at the Final. Combinations qualifying between one National Side Saddle Show and the next may carry forward the qualification, for that year only.

The **four** highest placed **Riding Horse, Hack (not ex 160cm), Cob or Hunter, Mare or Gelding, 4 years and over, ridden by a SSA Adult Member** qualify for the current year's **BSHA Championship Show Mears Ladies Show Horse Championship** and if already qualified the ticket will go to the next highest placed horse down to 5<sup>th</sup> place. Combinations qualifying after the current year's BSHA Championship Show may carry forward the qualification, to the following year. **SSA Members** who qualify for **The Mears Ladies Show Horse Championship, will not be required to join the BSHA** in order to compete in any **Side Saddle class** at the **BSHA National Championship Show**. If the BSHA Championship Show entries have closed at the time of qualification, competitors will not be charged a late entry fee for the Championship. **Competitors must wear a hat to current Safety Standard or above.**

### NEW 2024 CLASS

### THE SIDE SADDLE ASSOCIATION CONTEMPORARY LADIES SIDE SADDLE QUALIFIER

**SPECIAL OFFER FOR 2024 ONLY:** Shows may run the Contemporary Ladies Qualifier **as well as the Classical Ladies Qualifier at no extra cost.** However, if you choose to run a Contemporary Ladies only there will be a charge to affiliate as normal

- *The Judge shall be on the current SSA, SHBGB or BSHA Judges' Panels*
- *A maximum of 3 per SSA Area for Area run Shows*

Open to SSA Adult and Junior Members and Non-members riding a Native, Part Bred, Heavy or World Breed horse/pony side saddle. To be judged 25% suitability of horse/pony for rider, 25% manners and way of going for type, 25% rider, and 25% turnout of horse & rider. Conformation will not be taken into consideration. The Judge will request a short show. Traditional habits must be worn. **N.B.** Silk hats are permitted to be worn in this class AT ANY TIME OF THE DAY. Judges are requested to use the mark sheet provided. The highest placed horse/rider combination qualifies for the Final to be held at the National Side Saddle Show. One special rosette and the qualification card will be given to the qualifying combination at each show, this may not always be the winner; if the winner has already qualified they may be passed down to fourth place. *Qualifiers kindly sponsored by Southernden Side Saddles* Qualifying combinations are required to become Full Members of the SSA 21 days prior to the National Side Saddle Show or as soon as possible if qualified after that date to be eligible to compete at the Final. Combinations qualifying between one National Side Saddle Show and the next may carry forward the qualification, for that year only. **Competitors must wear a hat to current Safety Standard or above.**

### OTHER CLASSES

Whilst not offered as SSA affiliated classes, SSA "Special" Rosettes are available for purchase for the following classes. SSA Mark Sheets for these classes can be downloaded from the SSA Website: [www.sidesaddleassociation.co.uk](http://www.sidesaddleassociation.co.uk) "Affiliating Your Show"

#### WORKING HUNTER AND WORKING HUNTER PONY CLASSES

- The Judge shall be on the current SSA, SHBGB, BSHA, BSPS or P(UK) Judges' Panels
- These classes may be combined at the Show Organisers/Judge's discretion
- Competitors must wear a hat to current Safety Standard or above for all phases of these classes

#### SIDE SADDLE OPEN WORKING HUNTER

- Open to horses exceeding 148cm (14.2hh). Riders any age. Height of fences not to exceed 84cm (2'9"). The spread of fences shall not exceed the height. This class will be judged in accordance with SHBGB mark sheets. **Competitors must wear a hat to current Safety Standard or above for all phases.**

#### SIDE SADDLE OPEN WORKING HUNTER PONY

- Open to ponies not exceeding 153cm (15hh). Riders any age. Height of fences not to exceed 76cm (2'6"). If the class is split into height groups, ponies not exceeding 143cm (14hh), will jump a course not exceeding 69cm (2'3"), ponies not exceeding 133cm (13hh) a course not exceeding 61cm (2'). The spread of fences shall not exceed the height. This class will be judged in accordance with BSPS mark sheets. **Competitors must wear a hat to current Safety Standard or above for all phases.**

## SCHEDULE WORDING FOR 2024 cont ....

#### SIDE SADDLE EQUITATION JUMPING CLASSES

- The Judge shall be on the current SSA Judges' Panel
- To be run under SSA rules as they appear in the current Members' Handbook
- Competitors **must wear a hat to current Safety Standard or above.**
- Junior riders are **not permitted** to wear a spur or spur band in any class where jumping is involved
- Shows may title their class(es) at their discretion, i.e. Open, Intermediate, Novice, Junior, Beginners etc., but may not exceed the appropriate heights or spreads stipulated below
- It is recommended that the first fence is built on the right rein towards the collecting ring
- The first two fences **MUST NOT** be at maximum height
- Doubles and "Dog Leg" turns **MAY NOT** be included at any level
- Competitors may only compete once in any Equitation Jumping class, but may ride subsequent rounds, the National Side Saddle Show excepted, Hors Concours, on another horse or horses.
- Competitors may select at which height they would like to jump within their relevant class.
- The course shall consist of rustic or coloured fences, or a combination of both, and the number of fences must not exceed those stated.
- Maximum height and spread of fences:

##### **Junior Novice A: Maximum number of fences 8**

38 cm (1'3") max height, 30cm (1'0"), max spread, first 2 fences max height 30 cm (1'0")

##### **Junior Novice B: Maximum number of fences 8**

53 cm (1'9") max height, 38 cm (1'3"), max spread, first 2 fences max height 46 cm (1'6")

##### **Junior Open A: Maximum number of fences 8**

53 cm (1'9") max height, 38 cm (1'3"), max spread, first 2 fences max height 46 cm (1'6")

##### **Junior Open B: Maximum number of fences 8**

70 cm (2'3") max height, 46 cm (1'6"), max spread, first 2 fences max height 61 cm (2'0")

##### **Adult Novice A: Maximum number of fences 8**

70 cm (2'3") max height, 46 cm (1'6"), max spread, first 2 fences max height 61 cm (2'0")

##### **Adult Novice B: Maximum number of fences 8**

76 cm (2'6") max height, 61 cm (2'0"), max spread, first 2 fences max height 70 cm (2'3")

##### **Adult Intermediate A: Maximum number of fences 9**

76 cm (2'6") max height, 61 cm (2'0"), max spread, first 2 fences max height 70 cm (2'3")

##### **Adult Intermediate B: Maximum number of fences 9**

84 cm (2'9") max height, 70 cm (2'3"), max spread, first 2 fences max height 76 cm (2'6")

##### **Adult Open A: Maximum number of fences 10**

84 cm (2'9") max height, 70 cm (2'3"), max spread, first 2 fences max height 76 cm (2'6")
